


6. Accidental Release Measures

7. Handling and storage

Precautions for safe Handling

Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Avoid inhalation of vapours and mists, and skin or eye contact. Do not use near ignition sources. Do not pressurise, cut, heat or weld containers as they may contain hazardous residues. 


